# ADULT PROBATION - RESTROOM REMODEL

They do all their own drug screening which saves the cost of outsourcing. In the 30 years Parrish has worked in the office there have not been any updates to the restroom. Requesting \$1,500 to purchase materials to remodel it. They would do the work themselves. Helmer made the motion to approve up to \$2,000 and pay it from the cumulative courthouse fund.
