The Putnam County Board of Commissioners met on May 6, 2024, at 9:00 AM. The meeting was held at the Putnam County Courthouse. David Berry opened the meeting and the pledge to the flag was given.

## **EMS ORDINANCE - CHANGE FEES**

Auditor Berish stated she would be presenting the ordinance to the board. As the Director had stated in a previous meeting, the fees were changed by a house bill. The ordinance advertised for today's meeting is abiding by the law change. Berry made the motion to approve the ordinance 2024-05-06. Helmer seconded. The motion passed.

## FLOYD TWP FIRE DISTRICT - CUMULATIVE FIRE RATE

Berry read aloud the ordinance. The district makes the request per I.C. 36-8-14-2. The proposed fund will not exceed \$0.0333 on each \$100 of assessed valuation. Said tax rate will be levied beginning with taxes for 2024 pay 2025. Proof of publication of public hearing on the 16th of April 2024 was met. The fund is subject to approval by the Department of Local Government Finance. Berry made the motion to approve. Helmer seconded. The motion passed.

#### **BIG WALNUT WATER**

Jeff Mace was at the last meeting requesting funds from the county to help with the project. It had been brought up there may be some ARPA money that could be used. Helmer asked about r/o/w. Peck said they talked about it going underneath the gravel road. Berry asked if they were a not for profit. Mace said that they were. Peck said it will be a directional bore so it will have minimum impact on the top surface. Helmer made the motion to approve \$89,700 to be paid from ARPA. Berry seconded. The motion passed.

## **DUST CONTROL PROGRAM**

Highway Engineer Jim Peck went over the program. County has 15K appropriated. Berry made the motion to approve. Helmer seconded. The motion passed.

#### **HIGHWAY REPORT**

Peck presented:

- 1) Manhattan Road and Traffic Sign Inventory selection committee to review and rate RFP.
- 2) Annual Paving Operation May 15<sup>th</sup> is the targeted date to start paving. Starting in southern end of county and moving north. Commissioners thought they were starting north and going south? Peck said he would verify.
- 3) CCMG Paving plans out and bid opening at the May 20<sup>th</sup> Commissioners meeting. Award on June 3<sup>rd</sup> meeting.
- 4) Dump truck lease reached out to First National Bank. 4-year lease at 3.63% rate. Annual payment \$90,735. 5-year lease at 3.63% rate. Annual payment \$73,877. Did not have paperwork for today's meeting. Will get with them later.
- 5) POET seismic testing on county roads. Received certificate of insurance. Putnam County Highway is listed as additional insured.
- 6) Bridge 78 will need to further discuss engineering proposals and 2025 construction. Also discuss funding.
- 7) Enterprise truck lease received 4 of the 6 vehicles. Remaining 2 are being equipped with snowplows.
- 8) Additional request worker's comp. insurance premium increased.
- 9) Republic Service proposal recycling monthly fee is \$47.20 and 8-yd dumpster monthly fee \$146. Helmer made the motion to approve. Berry seconded. The motion passed.
- 10) ARPA 500K Berry made the motion to approve 1200 N and Heritage Lake. Helmer seconded. The motion passed.
