The Putnam County Board of Commissioners met on March 18, 2024, at 9:00 AM. The meeting was held at the Putnam County Courthouse. David Berry opened the meeting and the pledge to the flag was given.

LAKEVIEW DRIVE 375W

Mike Semak lives in Madison Township; he came to the meeting to discuss the road he has lived on for the last 23 years. It is a cul-de-sac with seven houses on it. He spoke to someone at the Highway department last week. They explained the county had a road plan; this road was not currently on it. The department did come out and fill in the potholes. Helmer said he drove out there Friday night to check the condition of the road. Berry said he wanted to go see the road too. The Commissioners will further discuss and get back with the property owners.

HIGHWAY REPORT

Peck presented:

- 1) Bridge replacement CR 500N & CR 25W) – remove existing bridge #297, replace with an aluminum box culvert. CR 25W closed the week of April 15th.
- 2) Manhattan Road & Traffic Sign Inventory – DBE requirements have been issued by INDOT. RFP has been submitted to INDOT. INDOT to issue (posting) date and deadline for submittal. Early coordination meeting is set for March 26th.
- 3) Dunbar Bypass Bridge – early coordination meeting on March 26th.
- 4) Cornstalk Covered Bridge Repairs – Steel plate installation & beam replacement next week. Will request INDOT approval to re-open bridge.
- 5) INDOT Statewide Safety Meeting – held on April 11th. Requesting elected officials to attend.
- 6) 825E south of 750 – culvert was lit on fire. A large portion of the pipe was ruined. The building inspector saw it over the weekend. The Highway Department put out signs twice and someone is removing them. Now they will be putting material in front of it to barricade it. Looking to repair Wednesday after utilities have been located.

TRUEROLL AGREEMENT

Auditor presented to the board. Ensley had reviewed prior to the meeting and saw no revisions needed. Helmer made the motion to approve. Berry seconded. The motion passed.
