## **SHERIFF - RESOURCE OFFICER**

South Putnam School asked the Sheriff to create a School Resource Officer that will be funded through a grant they received. It will consist of 48 hours a week for 40 weeks at a rate of \$45/hour. It will automatically renew year to year unless either party decides to stop the service. Discussion was made on the use of a vehicle. Helmer made a motion to approve. Berry seconded. The motion passed.

## **SHERIFF - TRANSFER OF VEHICLE**

Sheriff Baugh stated they have a blue 2010 Dodge Charger they would like to transfer to Van Bibber Lake Conservancy District to start a Town Marshall program. - 4) Truck Barn Damages Employee had bed up on truck and damaged a barn. Total damage to the truck is \$3,756.24. Damage to the barn was estimated at \$21,120. FBI Building requires 50% down to get started on repairs. Requesting the claim be made as an emergency claim. Asking for approval of the claim to be done as an emergency.
