Beck made the motion to add Fire District, 911 and Cloverdale Town Board topics to the agenda. Helmer seconded. The motion passed.

**REZONE**

Director Lisa Zeiner said the rezone on today's agenda needed to be pushed back to the June 16<sup>th</sup> meeting.

**DRAINAGE ISSUE AT 6527 N COUNTY ROAD 725 E**

Debbie Mitchell stated this has been an ongoing problem for a while. They have contacted the county and nothing has been done. She brought pictures to show the board of the water/drainage issue which is due to a county culvert.

Beck asked if it would be alright for him and the Highway Director Maddox to come and look at it and assess what needs to be done to fix the problem. Mitchell was agreeable to this and was okay with the county being on her property to get the problem fixed.

Once this is done, there will be two public hearings and then back to the Redevelopment Commission board. Clary asked the Commissioners to approve and sign the resolution presented today. Beck made the motion to approve. Helmer seconded. The motion passed.

**WALNUT CREEK FIRE DISTRICT BOARD APPOINTMENT**

**TOWN OF CLOVERDALE – WATER STUDY**

The total cost is \$11,500 and they are asking the county to pay half. Helmer made the motion to approve and pay it from the EDIT warchest. Beck seconded. The motion passed.
