The Putnam County Board of Commissioners met in Regular Session on June 20, 2022, at 9:00 AM at the Putnam County Courthouse. Rick Woodall opened the meeting and the pledge to the flag was given.

### **SHERIFF VEHICLES**

Matt Demmings wanted to inform the Commissioners they would be purchasing a Tahoe and 2 Traverse vehicles. And the equipment for them would be paid from commissary fund. They have money in the budget to pay the first year so it would only be a 2-year lease. They would be going before the Council. They were looking to take 5 out of commission, various vehicles.

### **PHI AIR MEDICAL**

Jill Spaulding came to discuss a countywide agreement with them for medical air flights. Current counties they work with are Fountain and Warren. Commissioners tabled to research. Spaulding will check back in a couple of weeks.

# **THRIVE 2023 FUNDING REQUEST**

They received \$12,097 in 2022, requesting \$18,309 for 2023. Jim Ensley put it in the file for next year's EDIT plan to review. Tabled request.

# **COVERED BRIDGE CERTIFICATION**

Auditor Kristina Berish submitted for signature. Berry made the motion to approve. Woodall seconded. The motion carried unanimously.

# **ROAD TO FAIRGROUNDS**

Jim Smith stated the main entrance to the fairgrounds needed to be done. It had been proposed the Fair Board would pay for the material and the Highway Department would do the work. July 22-29, 2022 fair.

Woodall said his concern was getting it done before the fair this year. Jim Peck said they would be able to do some of the work before and then finish it after the fair week. Woodall made motion to enter into agreement Fair Board pay material county pay for labor. Contingent upon the fair board approval and timing worked out between the Highway Department and the Fair Board. Helmer seconded. The motion carried unanimously.

# **VAN BIBBER ORDINANCE - SECURITY**

Jim Ensley said there was an Indiana code (9-21-18 Indiana Code Subsection 4.3) passed July 1, 2021, stating an entity could adopt ordinance and then a governing unit could approve and enforce security. If an agreement is approved, it would give authority to law enforcement to treat the roads in Van Bibber like they were county roads and could write tickets. It was unclear from Van Bibber and the Sheriff's Department what they were hoping to accomplish. Commissioners voted against until further clarification.
