The Putnam County Board of Commissioners met in Regular Session on December 19, 2022, at 9:00 AM at the Putnam County Courthouse. Rick Woodall opened the meeting and the pledge to the flag was given.

#### 12 LIBERTY BELL (MILL SPRINGS)

Tammy Rabe requested the repaying of her and other taxpayers' road. Presented pictures. She stated the road was partly dirt and gravel in spots. She stated there are a total of 8 other homes on this road. Rick stated that roads are on their agenda for next year. David Berry stated they would take a hard look at it.

#### PURDUE EXTENSION

Mark Evans presented the annual proposal for contractual service and copier lease. The contractual service is a 5% increase. Mark stated they are happy with the copier service they've been receiving and would like to stay with the current vendor. The price is locked in for 5 years. Discussion was made.

Rick Woodall made a motion to approve the contractual service agreement. David Berry seconded. The motion carried unanimously.

# **HOSPITAL BOARD APPOINTMENT**

# WILLIAM MORRISON FARM

Mr. Morrison stated his attorney contacted the County's. Requested she resubmit the compliance documents. After such, the judge ruled the intervener be removed. He presented a copy of the documents. Discussion was made.

# LEONDARD STEINMAN

Disabled Veteran Leonard Steinman stated they are direct descendants of the founders of Putnam County. He admired the crowd showing up at a commissioner meeting and the job they do.

# 2023 DUST BOWL

Marc O'Leary presented a request for the 2023 Dust Bowl. 2022 they had over 600 riders. Estimated economic impact to be over \$100,000. They would like to keep the route the same for 2023. July 22<sup>nd</sup> is the date of the event and expect the number of participants to increase as it did last year. David Berry made a motion to approve. Rick Woodall seconded. # **PLANNING & ZONING**

# <u>HIGHWAY</u>

Jim Peck – Last meeting opened the annual bids. Stone went up tremendously. Bituminous increase of over 22%. He presented a chart of the bids with amounts by material.

He stated they received two bids for fuel, Co Alliance & Petroleum Traders. A lengthy discussion was made.

Bridge 276 – beams installed, deck pans and barricades will be installed prior to winter shutdown. Deduct \$188,882. Rick Woodall made a motion to approve. Tom Helmer seconded. The motion carried unanimously.

Meeting with INDOT on January 3<sup>rd</sup> preventative local bridge maintenance.

Discussion was made on seeking funding for bridge maintenance. Applications open on January 2<sup>nd</sup>.

Rick Woodall stated they will be setting up a special meeting for discussion on 2023 road projects and the lack of funding. Discussion was made and the decision was made to meet January 11<sup>th</sup> at 2:30 at the Highway Department (open meeting).

The Bridge Inspection contract is going through the state agencies for approval.
