RAY POYNTER JR. AND STEVE CASH-PUTNAM COUNTY FARM BUREAU PUBLIC SAFETY

Ray Poynter Jr. spoke on behalf of Putnam County Farm Bureau, stating that the roadways due to tree overgrowth are a danger to the public and with the ditches being dug so deep vehicles have no place to go if they meet another vehicle. The Putnam County Farm Bureau is concerned with the safety of the public.

Mike Ricketts, Highway Supervisor said that the highway department has 2 trim mowers, and they are not in working condition at this time, and not enough manpower to run regular mowers on the roadsides.

WILLIAM AND ELLEN TUDOR

William and Ellen Tudor live at 331 Lincoln Hills at Heritage Lake, they are having drainage issues due to construction and excavation on the lot directly behind their property at 324 Lincoln Hills.

Rick Woodall told them that he would look into the issue.

SHERIFF

Chief Deputy, Matt Demmings requested approval to trade a van being used by maintenance supervisor, Tom Gilson as the van is costing more than it is worth to repair.

Matt said that they found a 2015 van with 69,000 miles at Andy Mohr, and they will give them a \$2,500.00 credit for the old van. The new van will be purchased with money from the commissary fund.

Bridge 276, the county has one more parcel to be acquired for the right of way. That parcel should be acquired this week.

The county portion of the bridge project is 20%.
