## **DUST BOWL**

Mr. O'Leary stated all 1000 spots for the 100-mile ride sold out in 3 days with participants from 28 states and 3 countries. His request is to use Putnam County roads on Saturday July 27th from 8:00 am to 6:00 pm. A portion of the event proceeds will go toward supporting cycling initiatives in west-central Indiana. Berry made a motion to approve. Helmer seconded. The motion carried.

#### FLOYD TOWNSHIP FIRE FUND

Michael buying a new fire truck. They have chosen to go the Cumulative fund route which has a lot of steps. He would like the Commissioners opinion on going forward with it. Berry said he thought it was a great idea and they are headed in the right direction. Ensley stated it's more of a County Council question.

## ADULT PROBATION BENEFIT CHANGE

Garret Nichols stated they are asking the county to pay for employee health insurance that is now paid by Alcohol and Drug fees. The employee switched tiers. According to Teresa Parrish they are losing money. Berry feels there is more than enough money in the fund according to auditor financial records. Helmer would like to table the matter for further investigation. Ensley stated they would need to get more information. Council members stated this should be brought up at budget time.

Brian Williams stated the wage study threw the nurses into an exempt category. They would like that to remain nonexempt. Brian stated the new job descriptions are needing signed by the Auditor's Office. Ensley stated he would advise making notes on the new job descriptions provided by the wage study what they approve of and don't.
